Our Compact Day Luncheon Speaker will be Roger Schlosser, Professor of Irish History, Grand Rapids Community College

Your Speaker, Roger M. Schlosser, (agus, Ruairi M. O'Cashel) was born in Grand Rapids to Bernard Schlosser and Kathyrn Schlosser, nee Coffey; was one of nine sons. Bernard traveled up to three weeks a out of the month for a Swiss pharmaceutical firm so the boys were raised as Irish Catholics by their Irish mother. Roger taught at Grand Rapids Community College for forty-one years in the History and Philosophy Departments. He started the GRCC Honors Program and was the founder and Director of the GRCC Irish Studies Program. His academic background included Western Michigan University, University College, Wales, and the University of Notre Dame. Since the late 1970s Roger has conducted foreign studies tours, seminars, and cultural programs beyond Ireland to western, central and eastern Europe, the former Soviet Union, the Scandinavian and Baltic countries, northern and southern Africa, Asian countries, Latin, and South American countries, and Cuba. Even in retirement he has continued to travel leading groups and with his wife Barbara. He has recently built a lodge on Drummond Island which can accommodate his four children, their spouses and the seven grand-children with beds left over. He is currently the President of the Gaelic League of West Michigan and the President of the Ancient Order of Hibernians, Fr. John Whalen McGee Division.

MICHIGAN MAYFLOWER SCHOLARSHIP AWARDS

There has been some date changes for the Scholarship Program. See page 4, "Important Dates to Remember", in this newsletter, for the specific dates.

The Board voted to increase our scholarship amounts. Beginning with the 2013 awards; 1st place \$2000, 2nd place \$1000, and 3rd place \$500. Entries (and/or description of the entries) have to be submitted to the Governor by 1 April 2013.

The web-site will have the entry application. All applicants must be Michigan Junior Members.

Our scholarship goal is to promote education regarding our Pilgrim Fathers and the history of the Mayflower ship, and the contributions they made to the growth of our country and the freedoms on which our government has been founded. We are also encouraging involvement with our Mayflower Juniors. The entries have to be historically accurate, and can be in any form, including writings, presentations, art projects, etc.

The General Society has made several By-Law changes, which requires us to do the same. Also we have some other By-Law issues, which the Michigan Society must address. Our Counselor, Mary Ellen Byrne, has presented the following. As required by our current by-laws, we are presenting the changes in a timely manner, before the vote. These changes will be voted on at the November 3 meeting.

Proposed Amendments Society of Mayflower Descendants in Michigan November 3, 2012 Annual Meeting Adopted:

1. Article II - Objectives

Amend Title by adding "and Purposes"
The title would then read "Objectives and Purposes"

- 2. In first sentence add "and purposes" between "objectives" and "of"
 First sentence would read "The objectives and purposes of the Society shall be:"
- 3. Add a new section:
- Section 3. The purposes of this society shall be: Notwithstanding any other provisions of these articles, the purposes for which the corporation is organized and operated are exclusively for charitable and educational purposes.

Rationale: to accurately state the purposes of the society and to conform to IRS language for 501(c)(3) status.

4. Article III, Section 4.

Delete "The name of" in first line. Delete "shall, after notice to such member," between "year" and "be" in second line. At end of last sentence add: "The Membership Secretary will send adequate notice to all members who will be dropped for non-payment." The Section would then read:

Any Regular Member whose Annual Dues remain unpaid at the end of the calendar year shall be dropped from the roll of membership at the discretion of the Board of Assistants. The Membership Secretary will send adequate notice to all members who will be dropped for non-payment."

Rationale: Clarify procedure for dropping a member for nonpayment of dues.

5. Article V, Duties of the Officers,

Section 5. Delete "The Board of Assistants, at its discretion, may appoint an independent auditor, who may be a member of the Society, to audit the Society's books." In its place insert:

An Auditing Committee of three members shall be appointed by the Governor at the Society's Annual meeting in November whose duty it shall be to audit (audit, review or compilation) the Treasurer's accounts at the close of the fiscal year and to report at the Spring meeting. The Board of Assistants may

recommend to the Auditing Committee that the Treasurer's accounts be submitted to a Certified Public Accountant for an audit, a review, or a compilation.

Rationale: to define the procedure for "audit" of the treasurer's records.

6. Article VII, Meetings, Section 3.

Insert "A" after Section 3 which would then read Section 3 A.

7. Add a new section:

Section 3 B. The Board of Assistants may hold electronic meetings when necessary, if the technology used provides for a deliberative assembly and the opportunity for simultaneous communication. Participation in a meeting in this manner constitutes a presence in person at the meeting. Electronic voting or voting by mail is authorized for the Board of Assistants if such vote is ratified at the next meeting of the Board of Assistants.

Rationale: Provide for electronic meetings and voting when necessary.

8. Article XII - Distribution of Assets upon Dissolution -delete article and insert new article.

Upon the dissolution of the corporation, assets shall be distributed to the General Society of Mayflower Descendants, or to such other Society of Mayflower Descendants in another state having a purpose similar to this Society, as may be selected by the Board of Assistants, and which enjoys exempt status under Section 501(c)(3) of the Internal Revenue Code for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any assets not so disposed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is located, exclusively for these purposes or to organization(s) as the Court shall determine, which are organized and operated exclusively for exempt purposes as described in section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Rationale: Use the current IRS approved language

9. Article XIII Parliamentary Authority

Add words "Newly Revised" between "Order" and "shall." Sentence would then read

The rules contained in the latest revision of Robert's Rules of Order Newly Revised shall govern all meetings of the society and of the Board of Assistants, provided that such rules are not inconsistent with the Bylaws of this Society or with the Constitution and bylaws of the General Society of Mayflower Descendants.

Rationale: Use the correct title for *Robert's Rules of Order Newly Revised*.

CHANGES AT THE LANSING STATE LIBRARY

There have been many-many rumors concerning the State Library of Michigan, in Lansing. They have recently made several changes, which may not be in the best interest of genealogy in general. These rumors have damaged the library's usage. Many persons are under the belief that the collection no longer exists.

The genealogy collection has been moved to the State Archives, which has limited space for expansion (or perhaps none at all). Many genealogy books have been placed in closed stack. Worst of all, the hours have been cut back to match the hours of the Archives; namely 1 p.m. to 5 p.m. and closed on weekends. This leaves no time for researchers who have jobs, outside their homes. I have spent many research hours at the library, and had to wait for the copy machines or film machines. This, at the time, was inconvenient, however, I now realize that that condition, is much better than having no access to the library at all.

This move has been explained as a protection of the collection, which was in threat of being moved out of the state library all together. This, as many of you know began with Governor Jennifer Granholm, whose concerns were not in the best interest of the general public, in this matter.

If the library would be closed a few days during the week and open on weekends, the client usage would improve. It is reasonable that more clients would mean more state funding. However, I was told by one librarian that a goal was to make the state library, strictly a government library. That maybe their goal for the space that the genealogy collection once housed. However, the number of government researchers will be considerably less than genealogy researchers, who used the collection in the past. We as tax payers, who support the state library, have a vested interest in the library and its usage, and we should have access to collections which are placed there to serve our interests. The Freedom of Information act, has a constitutional basis.

Another librarian told me that their focus (in the genealogy collection) will be only Michigan. However, most of us do not have the means to travel to New England, other states, foreign countries, etc. for our research. Many of our local libraries, have Michigan collections, especially of a local nature. Our state library should be competitive with other genealogy collections, ie. Fort Wayne's Allen County Library. Our state library should exist to serve its citizens.

The current library focus is confusing (even to them) and we as tax-payers and genealogists should clarify it for them. I am asking you to write letters to your state representatives and to the addresses, which I am providing here.

Please make this a priority, for our future.
